According to the National Center for Education Statistics (NCES), 11.7 percent of the nation's children enrolled in schools are enrolled in private schools. So more than 6.5 million students in kindergarten through grade 12 are attending non-government-funded schools across the nation ([www.capenet.org/facts.html](http://www.capenet.org/facts.html)). About 10 percent of that number are enrolled in Christian schools that are members of the Association of Christian Schools International.

Your school is a member of this association and is committed to providing the very best Christian school education for your students. We recognize your great commitment and the significant sacrifice that many of you make to pay for a distinctively different kind of education.

According to the latest data available from NCES, the average per-pupil cost of education in America in 2003–2004 was \$8,310 ([http://nces.ed.gov/pubs2006/expenditures/tables/table\\_3.asp](http://nces.ed.gov/pubs2006/expenditures/tables/table_3.asp)). If we were to assume an annual increase of 5 percent, the average per-pupil cost for this past school year would have been \$9,619 in U.S. government schools. A quick math exercise would then tell us that the 650,000 or so students who attend ACSI member schools, such as your Christian school, provided to America's taxpayers a savings of more than \$6 billion this past school year—and the savings has continued to increase yearly. As one of the hundreds of thousands of Christian school families, you have helped create this savings for the nation because of the considerable investment that you are making to send your children to a Christian school.

Each month, ACSI provides *Christian School Comment* to ACSI member schools as a publication they can make available to their school families.
